So, liability is \$72/acre (\$684 - \$612). The first dollar of payment happens when the harvest yield x harvest price is less than the \$684/acre Revenue Trigger. Max payout is the liability.

It's pretty simple to set up RPowerD coverage that meets the minimum revenue desired by your producer. RPowerD is available from 70-95% in 1% increments so agents and producers have lots of flexibility to create ranges of coverage. Additionally, RPowerD offers three ways to establish the minimum price that will be used to create the Revenue Trigger. These were reviewed in previous RPGs, here.

New for 90% and higher coverage Levels are April-June and July-September 90-day interval packages at a value price for those choosing RPowerD coverage levels of 90% and higher.


